**Wyoming County Board of Supervisors Chairwoman, Rebecca J. Ryan** announced as of Wednesday, April 28, 2021, the Wyoming County Health Department reports two thousand five hundred seventy-one (2,571) lab-confirmed positive community cases of COVID-19 among Wyoming County residents. This is an increase of fourteen (14) cases from the last reported increase on Tuesday, April 27, 2021.
