Wyoming County Board of Supervisors Chairwoman, **Rebecca J. Ryan** announced as of Thursday, April 29, 2021, the Wyoming County Health Department reports two thousand five hundred eighty-two (2,582) lab-confirmed positive community cases of COVID-19 among Wyoming County residents. This is an increase of twelve (12) cases from the last reported increase on Wednesday, April 28, 2021.
