Wyoming County Board of Supervisors Chairwoman, **Rebecca J. Ryan** announced as of Monday, May 3, 2021, the Wyoming County Health Department reports two thousand six hundred eighteen (2,618) lab-confirmed positive community cases of COVID-19 among Wyoming County residents. This is an increase of nineteen (19) cases from the last reported increase on Friday, April 30, 2021.
