Wyoming County Board of Supervisors Chairwoman, Rebecca J. Ryan announced as of Monday, May 10, 2021, the Wyoming County Health Department reports two thousand six hundred sixty-two (2,662) lab-confirmed positive community cases of COVID-19 among Wyoming County residents. This is an increase of eleven (11) cases from the last reported increase on Friday, May 7, 2021.
