**PRESS RELEASE**  
**May 12, 2021**

Wyoming County Board of Supervisors Chairwoman, **Rebecca J. Ryan** announced as of Wednesday, May 12, 2021, the Wyoming County Health Department reports two thousand six hundred eighty (2,680) lab-confirmed positive community cases of COVID-19 among Wyoming County residents. This is an increase of twelve (12) cases from the last reported increase on Tuesday, May 11, 2021.
