**PRESS RELEASE
May 14, 2021**

Residents still in need of a COVID-19 vaccine, may visit the **walk-in COVID-19 community vaccination clinic on Thursday May 20, 2021 from 1:00pm to 3:00pm**. The clinic will be at the First Congregational Church (Perry Center), 7209 State Route 20A in Perry. This will be the single dose Johnson and Johnson COVID-19 vaccination for anyone 18 years and older. Please bring identification and proof of insurance to the clinic. If you are uninsured, there is no charge for vaccine administration. Call the Health Department at 786-8890 with questions. You may choose to pre-register [HERE](#).

NEW: There are currently 251 Wyoming County residents quarantined due to exposure to COVID-19, as the virus continues to circulate throughout Wyoming County. The best way to prevent mandatory quarantine is to receive a COVID-19 vaccine. The percentage of positive tests per day in Wyoming County is 3.2%, compared to the Finger Lakes Region (including Monroe County) at 2.7% and NYS rate of 1.3%.

On Thursday, the Centers for Disease Control & Prevention (CDC) released [new guidance](#) regarding mask use for those who are fully vaccinated against COVID-19 (defined as 2 weeks following the second shot in the Moderna & Pfizer series or 2 weeks following the single dose Johnson & Johnson vaccine). The updated CDC guidance **does not override** mask guidelines issued by New York State. It is anticipated that the State will release updated guidelines in the coming days. All New Yorkers should continue to follow current NYS guidance regarding mask use, social distancing, and capacity limits.

Wyoming County Board of Supervisors Chairwoman, Rebecca J. Ryan announced as of Friday, May 14, 2021, the Wyoming County Health Department reports two thousand six hundred ninety-seven (2,697) lab-confirmed positive community cases of COVID-19 among Wyoming County residents. This is an increase of ten (10) cases from the last reported increase on Thursday, May 13, 2021.
