NEW: New York State will adopt the new CDC guidelines effective this Wednesday, May 19. The Centers for Disease Control and Prevention eased mask-wearing guidance for **fully vaccinated** people allowing them to stop wearing masks outdoors, in crowds, and in most indoor settings. Additional re-opening guidance can be found on the [NY Forward](#) website.

As New York State lifts many COVID restrictions later this week, some locations may require proof of COVID vaccination or a negative test. Learn more about the “Excelsior Pass” as secure, digital proof of COVID-19 vaccination or negative test results. The best way to protect yourself and others as NYS re-opens is to be vaccinated. Residents still in need of a COVID-19 vaccine, may visit the **walk-in COVID-19 community vaccination clinic on Thursday May 20, 2021 from 1:00pm to 3:00pm**. The clinic will be at the First Congregational Church (Perry Center), 7209 State Route 20A in Perry. This will be the single dose Johnson and Johnson COVID-19 vaccination for anyone 18 years and older. Please bring identification and proof of insurance to the clinic. Wyoming County Board of Supervisors Chairwoman, Rebecca J. Ryan announced as of Monday, May 17, 2021, the Wyoming County Health Department reports two thousand seven hundred fourteen (2,714) lab-confirmed positive community cases of COVID-19 among Wyoming County residents. This is an increase of seventeen (17) cases from the last reported increase on Friday, May 14, 2021.
