Residents still in need of a COVID-19 vaccine, may visit the **walk-in COVID-19 community vaccination clinic on Thursday May 20, 2021 from 1:00pm to 3:00pm**. The clinic will be at the First Congregational Church (Perry Center), 7209 State Route 20A in Perry. This will be the single dose Johnson and Johnson COVID-19 vaccination for anyone 18 years and older. Please bring identification and proof of insurance to the clinic. If you are uninsured, there is no charge for vaccine administration. Call the Health Department at 786-8890 with questions. You may choose to pre-register [HERE](#).

Wyoming County Board of Supervisors Chairwoman, Rebecca J. Ryan announced as of Tuesday, May 18, 2021, the Wyoming County Health Department reports two thousand seven hundred seventeen (2,717) lab-confirmed positive community cases of COVID-19 among Wyoming County residents. This is an increase of three (3) cases from the last reported increase on Monday, May 17, 2021.
