NEW: Vaccination Clinic

There will be Pfizer community vaccination clinic Monday, August 30th from 12:00PM to 3:00PM at the Wyoming County Health Department.

Pfizer vaccine is for anyone 12 years and older. Children under 18 must be accompanied by a parent or guardian that can provide consent. Please bring identification and proof of insurance. If you are uninsured, there is no charge. Call the Health Department at 786-8890 with questions.

Wyoming County Board of Supervisors Chairwoman, Rebecca J. Ryan announced as of Thursday, August 26, 2021, the Wyoming County Health Department reports two thousand eight hundred fifty-six (2,856) lab-confirmed positive community cases of COVID-19 among Wyoming County residents. There is an increase of twenty-one (21) cases since the last reported increase on Thursday, August 19, 2021. There are currently sixteen (16) laboratory-confirmed active COVID-19 cases in Wyoming County.

The Centers for Disease Control characterizes COVID community transmission in Wyoming County as “Substantial” between August 18 and August 24, 2021. Currently, the CDC suggests transmission mitigation strategies that include the wearing of face masks for vaccinated and non-vaccinated individuals indoors and in public settings. The community should also continue to promote behaviors that prevent spread and maintain healthy environments, such as cleaning high touch surfaces, ensuring clean ventilation systems, and allowing for social distancing.
