NEW: Vaccination Clinics

There will be Pfizer community vaccination clinic Friday, August 20th, from 9:00 AM to 12:00 PM at the Wyoming County Health Department.

On Monday, August 23rd from 11:00 AM to 1:00 PM there will be Pfizer community vaccination clinic at Stevens Memorial Community Library in Attica.

Pfizer vaccine is for anyone 12years and older. Children under 18 must be accompanied by a parent or guardian that can provide consent. Please bring identification and proof of insurance. If you are uninsured, there is no charge. Call the Health Department at 786-8890 with questions.

Wyoming County Board of Supervisors Chairwoman, Rebecca J. Ryan announced as of Thursday, August 19, 2021, the Wyoming County Health Department reports two thousand eight hundred thirty-five (2,835) lab-confirmed positive community cases of COVID-19 among Wyoming County residents. There is an increase of seventeen (17) cases since the last reported increase on Thursday, August 12, 2021. There are currently fourteen (14) laboratory-confirmed active COVID-19 cases in Wyoming County.

The Centers for Disease Control (CDC) characterizes COVID community transmission in Wyoming County as “Moderate” between August 11 and August 17, 2021. Currently, the CDC suggests transmission mitigation strategies that include the wearing of face masks for non-vaccinated residents. The community should also continue to promote behaviors that prevent spread and maintain healthy environments, such as cleaning high touch surfaces, ensuring clean ventilation systems, and allowing for social distancing. Further mitigation strategies and suggestions will be announced should the COVID transmission status change in Wyoming County.
