Wyoming County has had a 9.5% positivity rate over the last 7 days, far above the statewide totals. For unvaccinated adults, the pandemic remains a daily threat, and a personal choice to stay unvaccinated will continue to put you and those around you at risk.

Unfortunately, large-scale gatherings increase the chances of contracting COVID-19 — especially in light of the virus' Delta variant. Thanksgiving is just a week away, get all your plans in place to celebrate safely. Remember: get the vaccine if you haven't, get a booster if you have, wear a mask, stay home if you feel sick & keep practicing social distancing.

The COVID-19 vaccine is safe and effective. Anyone 5 years and older are eligible to receive a vaccine. Wyoming County Health Department encourages Wyoming County residents who are not fully vaccinated to begin their COVID-19 vaccine series. COVID-19 vaccination is especially important for youth and families attending school or child care.

**YOUTH VACCINATIONS AT MASS VAX SITES**

New York's mass vaccination sites in Buffalo and Rochester are now administering the COVID-19 vaccine to newly eligible 5 to 11 year-olds. Parents and guardians can make appointments at a state-run vaccine site for their child at [ny.gov/vaccine](http://ny.gov/vaccine).

**Wyoming County Board of Supervisors Chairwoman, Rebecca J. Ryan** announced as of Thursday, November 18, 2021, the Wyoming County Health Department reports three thousand nine hundred eighty (3,980) lab-confirmed positive community cases of COVID-19 among Wyoming County residents. There is an increase of one hundred eighty-four (184) cases since the last reported increase on Wednesday, November 10, 2021. There are currently one hundred eleven (111) laboratory-confirmed active COVID-19 cases in Wyoming County.

**The Centers for Disease Control characterizes COVID community transmission in Wyoming County as “High” between November 10, 2021 – November 16, 2021.**
